### Reservations & Payments

Reservations may be made by phoning 888-785-7767, 301-570-0800 or (888) 850-6831. Reservation lines will be open Monday-Friday 9am-5pm. All reservations will be accepted on a first come, first served basis, and will be acknowledged with a printed confirmation. Full payment is due at time of booking and may be made by Visa, MasterCard, or personal check. All credit card charges will appear on your statement as a charge from Collegiate Athletic Travel. ### Air-Only Packages

Charter air transportation is available for those with their own accommodations. The price is \$495 per person and includes roundtrip air transportation.

### Land-Only Packages

Land tours are available to those who wish to drive or otherwise travel to the bowl game on their own. These tours include all items listed as "tour features" exclusive of air transportation to destination city, airport/hotel transfers, and baggage handling.

### Game tickets

Game tickets are not included in the tour package. Bowl game tickets can be purchased from the Terrapin Ticket Office at (301) 314-7070 or (800) 462-8377.

### Changes, Cancellations and Refunds

Once a reservation has been made, it is considered paid in full and is non-refundable. Any name changes or changes to package arrangements made after registration will result in a \$25 charge per change. No name changes will be accepted after December 15, 2003. No refunds will be issued for unused transportation or for other package inclusions not used by the participant.

STI/CAT shall not be responsible for losses or additional expenses incurred by tour participants that result from weather or mechanical related delays of aircraft or other transport modes, sickness, weather, strike, government disorder, war, acts of God, quarantine, criminal acts, or other causes. Nor does STI/CAT assume any liability for personal injury, damage to or loss of personal possessions, or accidents and/or delays that result from negligence, default or "failure to perform" on the part of any subcontracted travel or service provider. All such losses or expenses will be borne by the tour participant as tour rates provide only for arrangements as detailed in the brochure. STI/CAT reserves the right to refuse to accept or retain any person as a member of the tour at anytime. STI/CAT also reserves the right to substitute comparable accommodations and transportation and to make any changes in the itinerary where deemed necessary.
